





## THE POWER OF MERCY ADVISORY COMMITTEE

## PUBLIC NOTICE

The Power of Mercy Advisory Committee is a constitutional body established pursuant to Article 133 of the Constitution of Kenya with a mandate to advice His Excellency the President in the exercise of the power of mercy.

In addition to the constitutional mandate, The Power of Mercy Act, 2011 assigns the Committee with functions that support its work including to undertake or commission research and to collect data on matters relating to the power of mercy.

The Committee has consequently partnered with the National Crime Research Centre (NCRC) to conduct a national public debate that will solicit the views of the general public on the subject of capital offences and capital punishment in Kenya. The exercise specifically seeks to:

- (i) Provide a platform for Kenyans to have a say in the review of capital punishment and on what form of punishment capital offenders should be subjected to;
- (ii) Open a dialogue on what Kenyans want in regard to handling of capital offenders and management of capital offences;
- (iii) Bring stakeholders together to open the debate on death penalty sentence;
- (iv) Document the findings of the public opinion;
- (v) Recommend measures of alternative punishment for capital offences;
- (vi) Recommend any such other legal, political and administrative measures as the Committee may deem necessary;
- (vii) Perform any other task that the Committee may deem necessary in fulfilling the above:
- (viii) Report its findings and recommendations within Eight (8) months.
